Sub.: Local transfer of students from one KV to another KV within the same station during the Session 2023-24- Reg.


Madam/Sir,

With reference to the aforesaid subject it is to state that the **Local Transfer** of students from **one KV to another KV** with in the same station will be considered by this office in the month of **July 2023**. You are therefore requested to notify the same for information of all the concerned Parents/Guardians and **display the schedule of activities (enclosed herewith) on School Notice Board and update the same on Vidyalaya Website**. The application of the parents seeking local transfer of students should be considered by following the procedure as mentioned below:

1. The Local transfer application forms are to be prepared in Quadruplicate (4 sets) & made available to the parents, seeking local transfer of their wards.
2. The Principal of the KV where the child is presently studying will keep one copy of the application for official record & after endorsement shall send remaining three copies to the Principal of the KV where admission is sought by the parent on first priority.
3. Principal of the KV where the Local transfer is desired will send one copy; complete in all aspects, to the Cluster In-Charge Principal after her/his endorsement, keeping a copy in the Vidyalaya for official record & handover one copy to the concerned parent.
4. Generally, no local transfers shall be granted in project sector KVs however in special cases where the class strength is **below 45** in a project KV, the local transfer may be considered by the RO with **prior approval of the Chairman VMC & recommendation of the Principal**.
5. Priority to local transfer will be accorded to the students in the order of priority category (**Service Category**) as mentioned in KVS admission guidelines based on the reasons listed below:
 - a) Medical ground of the student of the KV.
 - b) Sibling is studying in the KV where local transfer is sought.
 - c) Allotment of govt. accommodation to the parent.
 - d) Parents shifted to permanent residence of their own.

- e) Change of job by the parent closer to the KV where local transfer is sought.
- f) Any other reason other than listed from (a) to (e).
6. Local transfer cases would be screened by the **Screening Committee constituted at Cluster level** by the Cluster In-Charge Principal. Screening Committee under the Chairpersonship of the Cluster In-Charge will scrutinize the applications & then send only the genuine cases for further action at Regional Office. **No KV should send the local transfer forms directly to RO without scrutinizing them.**
7. Genuine local transfer cases may be sent by the Cluster I/C Principal to the Regional Office in a single bunch for further process at the Regional Office.
8. Local transfer will be considered only in the month of July 2023 after fresh admissions are over.
9. The time line to be followed by the KVs for local transfer of genuine cases of students is as follows-
- a) Distribution of local transfer forms to the parents – 3rd July 2023 onwards.
- b) Submission of duly filled local transfer forms by the Parents to the concerned KV – 10th July 2023.**
- c) Sending of duly filled local transfer forms from other KVs to Cluster I/C KV – Latest by 18th July 2023.
- d) Scrutiny of local transfer forms by Screening Committee at Cluster level – Latest by 24th July 2023.
- e) Sending of genuine local transfer cases to the Regional Office (Only through Cluster I/C) for further action – Latest by 28th July 2023.
10. **Under No circumstances parents should be advised to go to the Regional Office for local transfer.**
11. If the parent is transferred beyond a distance of 20 KMs after a minimum period of stay that it would be considered as the case of 'transfer' as indicated in Admission Guidelines 2023-24. Such case of transfer, from Gandhinagar to Ahmedabad and vice versa, will not be included under local transfer but these applications need to be handled at Vidyalaya level as other transfer cases.
